At the same time, the portfolio manager will look for companies with above average dividend yields (superior to that of the S&P/TSX Composite Index). Minimizing volatility through sound diversification across industry sectors will also remain a priority for the Dividend Basket. An emphasis will be put on companies with solid balance sheets, adequate dividend coverage and a good dividend payment history.
