For the most part, the Basket's investment process is based on fundamental research. Security selection is based on knowledge of the company, its industry and its growth prospects. An extensive credit analysis for each security and an assessment of risk profiles, relative performance and general conditions are completed in order to confirm the selection and the relative weight of each component security.
